Report on the election of new members of the Executive Board

On Monday May 13, 2024, starting at **5:16 pm**, the election of new members of the OPTICA student chapter took place, under the direction of the supervisor, Doctor Max-Fréjus SANYA, Lecturer-Researcher at the Ecole Polytechnique de l'Université d'Abomey-Calavi (EPAC-UAC).

Prior to the election, a number of points were discussed, including

- Presentation of the various positions on the chapter's executive board. Initially set at five (5) positions, this number has been revised to seven (7) with the addition of two positions. These positions are as follows:
 1. Président
 2. Vice-Président
 3. General Secretary
 4. Assistant General Secretary
 5. General Treasurer
 6. Assistant General Treasurer
 7. Communications Manager
- Chapter activities. Members are required to report on all activities by December 5.
- The room in which the conference will be held on Thursday, May 16, 2024, the International Day of Light. The EPAC administration room was chosen for this event.

Next, the election of new members took place, position by position:

1. President of the Executive Board

For the position of President, only one candidate was put forward: the former President of the Board, **Mme MAGNIDET Fifamè Merci-Ange**, who was re-elected for a further term.

2. General Treasurer

Two candidates applied for this position: Mr **BONOU Sèdjro Habib** and Mr **CODJIA Boris Canisius**. Twelve (12) people voted, with 6 votes each. Despite a close vote, Mr **CODJIA Boris Canisius**, a specialist in the optics field, was favored. As the position of Vice-Chairman is vacant, it was unanimously awarded with the agreement of the candidate Mr. **CODJIA Boris Canisius**. Thus, candidate **BONOU Sèdjro Habib** was selected for the position of General Treasurer. The chapter now has a new Vice-President and a new General Treasurer.

3. Assistant General Treasurer

Only one person applied for this position, which directly assures his appointment: Mr **AVOHOU Prince Boris**.

4. General Secretary

Mr **KOTANMI Amédé Florian** was the only candidate for this position, which directly secured his election.

5. Assistant General Secretary

As for the two previous posts, only one candidate was put forward for this position: Mr **SEWADE Mahougnon Fadel**, who was thus directly elected.

6. Communications Manager

Two candidatures were received for this position, those of Mr **GOHOUÉ Boris Ulrich** and Mr **AGOSSOU Kéhoun dé Arcadius**. The result of the vote count was 8 votes for the former and 5 for the latter, with 1 invalid ballot. This puts Mr **GOHOUÉ Boris Ulrich** at the head of the chapter's communication. The other candidate, having demonstrated his commitment to the chapter, will be promised by the supervisor the creation of a new position of deputy communications manager, which he will occupy after a review of the chapter's texts and charter.
